# FFI UE / Resident

European doctors who carry out their medical specialty in an European Union (EU) country or in Switzerland can carry out their specialization in France, as long as they have had a good start in their specialization for at least one year.

#### **Conditions**

- Candidates are doctors who are nationals of the EU or Switzerland, holders of a EU doctor of medicine diploma, who have been in the process of specialization for at least one year.
- Candidates may apply via a French university or apply directly to the Institut Curie.
- Hold an EU medical doctor diploma.
- Have practiced his or her specialization for one year in the country of origin.
- The place of practice: a department / reception service approved for the training of interns in the specialty.
- The training program is identical to that for French interns.
- They have the status of EU Resident.

### **Duration of the formation**

- The duration of this training may not exceed three semesters.

# Language level

- Proof of a diploma of knowledge of the French language equivalent to level B2 (TCF, TEF, DELF).

### **Financing**

- This internship is financed either by the home institution or by a third party, or by the Institut Curie.

## How to apply

- Candidates must complete the registration form on the Institut Curie's teaching website and attach the documents requested for the analysis of their application.

or

- Candidates register at the University of Paris and will then be assigned to the Institut Curie. They must complete the online registration form on the Institut Curie's training website, and attach the documents requested for the follow-up of their file.



# "Faisant en fonction d'interne" / Resident (3ème cycle en médecine - CNG)

It is a training course allowing access to postgraduate medical specialization in France, under the same conditions as French interns.

### **Conditions**

- Applicants are students from the European Union (EU) or other States party to the Agreement on the European Economic Area, the Swiss Confederation or the Principality of Andorra, who have completed the 2nd cycle of medical studies in their country of origin.
- Candidates register on the website of the "Centre National de Gestion" (CNG), which is accessible during the registration period from 1st to 31 March of the year in which the tests are taken.
- Access to the registration interface and all information relating to this competition can also be obtained on the following website: <a href="www.cng.sante.fr">www.cng.sante.fr</a>, under the headings: competitions and exams / medical-practitioner competitions / special European competitions (SSC).
- The training program is identical to that of the ECN and to the conditions for French interns (training courses, approved training centers, statutes, etc.).
- They have the status of "Faisant Fonction d'Interne" (FFI).

### **Duration of the formation**

- The duration of this training may be equivalent to the entire 3rd cycle of medical studies in France.

### **Level of language**

- Proof of a diploma of knowledge of the French language equivalent to level B2 (TCF, TEF, DELF) is required.

## **Financing**

- Candidates will be paid by the Institut Curie on the same salary basis as French interns.
